- NEET- UG Counseling 2022 is conducted online by the Medical Counseling Committee (MCC), DGHS, New Delhi for admission to MBBS Course offered by Deemed Universities.
- All the Participating Candidates are hereby advised to read carefully the Information Bulletin, Counseling procedure, Institute information and Seat matrix posted on the official website of MCC i.e., www.mcc.nic.in and get register for seeking admission to MBBS Course in GITAM Institute of Medical Sciences and Research (GIMSR), GITAM (Deemed to be University), Visakhapatnam.

1. Reporting Procedure:

- The candidates who have been allotted a seat in MBBS through MCC UG Medical Counseling 2022 have been directed to complete the physical reporting formalities at GITAM Institute of Medical Sciences and Research (GIMSR) as per the reporting schedule displayed by MCC.
- The candidates should report along with original certificates / documents and demand draft / online transfer for payment of tuition fee.
- The reporting details of the candidate will be uploaded at MCC web portal by the GIMSR. The Provisional Admission letter will be generated from MCC and the same will be issued to the candidate signed by the Principal authority.

5. Eligibility:

Candidates should satisfy the eligibility requirement as per the NEET UG (MBBS) Information Brochure - 2022 of MCC Counseling and the eligibility requirements as prescribed by the National Medical Commission (NMC).

6. Admission formality:

For completing the reporting and admission formality at GITAM Institute of Medical Sciences and Research (GIMSR), Visakhapatnam, the candidate has to pay the first year prescribed fee in full to the GITAM Institute of Medical Sciences and Research Account.

7. NRI quota seats:

For foreign citizens including OCI, PIO, NRI and NRI sponsored candidates, the prescribed tuition fee must be paid in US Dollars (\$) only from the sponsor account and for the same, candidate must produce proof of the transaction made from the sponsor account.

8. Mode of Fee payment for Management / paid seats:

1. The fee can be paid through Demand draft drawn in the name of GITAM Institute of Medical Sciences and Research payable at Visakhapatnam.

11. List of original certificates / documents for general and NRI category candidates:

The following original certificates / documents are to be submitted at the time of reporting to the GIMSR along with 2 sets of photo copies of certificates and 6 latest passport size photos.

- MCC allotment letter
- NEET UG 2022 Hall Ticket / Admit card issued by NTA
- NEET UG 2022 Result / Rank letter issued by NTA
- 10th Marks card or equivalent for proof of Date of Birth
- 12th Marks card or equivalent
- NRI candidates must have passed the 12th Grade Diploma with Physics, Chemistry, Biology (Botany and Zoology) and English during their 11th and 12th year course of study
- Transfer Certificate and Conduct Certificate
- Fee Payment details
- Copy of Aadhar card (self attested copy of candidate and parent)
- Community (SC/ST/OBC) Certificate / Disability Certificate, if applicable

In addition to the above, the candidates who have been allotted seat under NRI / NRI sponsored category, the following original documents have to be submitted at the time of reporting:

1. Documents claiming that the sponsor is an NRI (Passport, Visa)
2. Relationship of NRI with the candidate.
3. Affidavit from the sponsor to sponsor the entire course fee of the candidate duly Notarized.
4. Embassy – certificate of the sponsor (Certificate from the Consulate)

Note: Candidates without original certificates / documents and the details of payment of fee will not be allowed to take admission at GITAM Institute of Medical Sciences and Research (GIMSR).

Prohibition of Ragging:
